TYPE OF DATA PROCESSED, PURPOSE AND LEGAL BASIS OF THE PROCESSING

Browsing data

The computer systems and software procedures used to operate this website capture, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols.

These information arenot collected to be associated with identified interested parties, but by its very nature could allow users to be identified, through processing and association with data held by third parties..

This category of data includes the IP addresses or domain names of the computers used by users connecting to the site, the URI (Uniform Resource Identifier) notation addresses of the resources requested, the time of the request, the method used in submitting the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the user's operating system and computer environment. These data are used for the sole purpose of obtaining anonymous statistical information about the use of the site and to check its correct operation and are immediately deleted after processing. The data could be used to ascertain responsibility in case of alleged computer crimes against the site: besides this case, currently the data on web contacts do not remain for more than one month.

The legal basis for the processing is therefore a legitimate interest of the owner in the performance and improvement of the site services provided.

- Marketing: by way of example, sending by automated contact methods (such as sms and email) and traditional methods (such as telephone calls with operator and traditional mail) promotional and commercial communications related to services offered by the Company or reporting of company events, as well as the implementation of market studies and statistical analysis. The purpose of which becomes the consent, optional and revocable at any time of the Data Subject.

PROVISION OF DATA

DATA RECIPIENTS

RIGHTS OF THE DATA SUBJECTS, RIGHT TO PROPOSE A COMPLAINT AND REVOCATION OF CONSENT

Data Subjects have the right at any time to request access to their personal data, rectification, cancellation, restriction of the same, to object to the processing and to exercise the right to data portability. In any case, the data subject has the right to revoke at any time any consent given to the processing of data, without prejudice to the lawfulness of the processing based on the consent given before revocation.
